 - All the members were instructed to maintain absolute confidentiality of all discussions held during the IEC meetings.
 - It is informed that IEC is responsible for monitoring all the research proposals that involve human beings under its considerations.
 - Clearance from IEC is mandatory for publication of any research work.
 - Research, where low risk is involved, may pass through Expedited review committee and the minutes should be approved by subsequent IEC.
 - It is informed that the IUC Manual was prepared based on ICMR and WHO guidelines.
 - 6. It was decided by all the members that, hereafter, all the research proposals (M.Phil/Ph.D, etc.,) of both FDMSE and GAPEY should be submitted to IEC for clearance after seeking approval from Institutional Research Committee.
 - 7. It was resolve to approve the manual comprising the guidelines of IEC.
 - 8. No research proposal was submitted for clearance.
