### **Notes:** 1. Class attendance criteria (for appearing the end-semester examination):

#### 1) Minimum 80%

2) If class attendance is in between 65-79% then the student may appear in that paper after getting due permission from the Dean / Head of the department & <u>Registrar</u> and by paying a condonation fee of Rs.300/- per paper/course. Condonation will be granted only in cases where the authority is satisfied that the student could not keep up the class attendance criteria due to some genuine reasons.

3) In extra-ordinary circumstances (prolong ill-ness, bereavement in the family affecting the studies etc) if the percent of attendance falls below 65% but ordinarily not below 60%, the dean / HOD may recommend after due verification of the genuineness of the case, that the candidate concerned be given 'make-up' of attendances / classes / assignments / seminars & the Registrar of the main campus or Administrative Heads of the off-campus centres will need to grant the necessary permission, on obtaining which the faculty or Department concerned will arrange for the make-up of attendances, so that the candidate may be enabled to appear in the examination without having to loose the semester. The student may appear in the examination of that paper after fulfilling the minimum 65% attendance criteria subject to the recommendation of the Dean/ HOD & permission from the Registrar and paying the fine of Rs.500/- per paper/course. In all other cases the student has to repeat the course in the next available semester after getting necessary permission from the authority. (See examination rules)
