- NOW, THEREFORE, in exercise of the powers vested under Section 15(3) (a) 3. of the NCTE Act, 1993, the Southern Regional Committee, NCTE hereby grants recognition to Ramakrishna Mission Vivekananda University, Faculty of General & Adapted Physical Education & Yoga, SRKV Post, Perlyanaickenpalayam, Coimbatore District-641020, Tamilnadu for conducting M.P.Ed Course of two years duration with an annual intake of 30 from the academic session 2008-09 under clause 7(11) of NCTE(Recognition Norms & Procedure) Regulations, 2007 subject of fulfillment of the following conditions:
  - The endowment fund of Rs.5 lakhs and reserve fund of Rs.3 lakhs kept 1. in joint account with SRC, NCTE should be maintained always. Loan raising or Mortgaging of FDRs shall not be done.
  - The institution shall comply with the various other norms and standards 11. prescribed in the NCTE regulations, as amended from time to time.
  - The institution shall make admission only after it obtains affiliation from 111. the examining body in terms of clause 8(12) of the NCTE( Recognition Norms & Procedure) Regulations, 2007.

#### ORDER

WHEREAS, in exercise of the powers conferred by sub-section(2) of Section 32 of the National Council for Teacher Education Act, 1993(73 of 1993), and in supersession of the National Council for Teacher Education [Recognition Norms and Procedure] Regulations, 2009, the National Council for Teacher Education has notified the Regulations, 2014 on 1.12.2014.

- 2. AND WHEREAS, the institution Ramakrishna Mission Vivekananda University, Faculty of General & Adapted Physical Education & Yoga, SRKV Post, Periyanaickenpalayam, Coimbatore District 641020, Tamilnadu has by affidavit consented to come under New Regulations and sought for 100 intake in B.P.Ed.
- 3. AND WHEREAS, on scrutiny it is found that the decision of SRC to cause composite inspection is pending.
- **4. AND WHEREAS**, it has been decided to permit the institution to have one basic unit of 100 students (two sections of 50 each) subject to the decision of the SRC on the report of inspection to be conducted and the institution fulfilling following conditions namely.
  - The institution shall submit the documents before 31.10.2015, with documentary proof failing which recognition will be withdrawn.
  - II. The institution shall appoint additional staff as per Regulations, 2014 and submit approved staff list to the Regional Committees with required documents by October 31, 2015
  - III. The Regional Committees shall arrange for verification of documents, check adherence by 20 Feb. 2016. If it is found by the Regional Committee that the institution fails to comply with the new teaching staff requirements, the institution shall not be permitted to admit students for the academic year 2016-2017.
- 5. NOW THEREFORE, in the light of the above and in terms of Section 14(3) (a) of NCTE, Act and in accordance with the Regulations, 2014, the Southern Regional Committee. NCTE hereby grants recognition to Ramakrishna Mission Vivekananda University, Faculty of General & Adapted Physical Education & Yoga, SRKV Post, Periyanaickenpalayam, Coimbatore District 641020, Tamilnadu for conducting B.P.Ed programme of two years duration with an annual intake of one basic unit of 100 (two sections of 50 students each) from the academic session 2015-16 subject to fulfilment of the conditions mentioned at 4(I) herein by 31.10.2015 and at 4(II) to 4(III).
- 6. Further, the recognition is subject to fulfilment of other requirements as may be prescribed by other regulatory bodies like UGC, affiliating University/Body, the State Government etc. as applicable.
- 7. The institution shall submit to the Regional Committee a Self- Appraisal Report at the end of each academic year along with the statement of annual accounts duly audited by a Chartered Accountant
